- 3. In terms of the aforesaid Notice and as per the provisions of Section 108 of the Companies Act, 2013 (the 2013 Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, the remote e-voting facility was kept open from Friday, September 24, 2021 (9:00 a.m.) till Sunday, September 26, 2021 (5.00 p.m.) and Members were requested to cast their votes electronically conveying their assent or dissent in respect of the resolution on the e-voting platform provided by National Securities Depository Limited (NSDL).
- 4. The Members holding equity shares as on the "cut-off date" i.e. September 20, 2021 were entitled to vote on the resolutions proposed in the Notice calling the 117th Annual General Meeting.
- 5. At the end of the remote e-voting period on Sunday, September 26, 2021 (5:00 p.m.), the voting portal of the service provider was blocked forthwith.

Immediately after the conclusion of voting at the venue of the AGM on September 27, 2021, the votes cast at the venue were counted, thereafter the votes cast through remote e-voting were unblocked in the presence of two persons, who acted as witnesses as prescribed under sub-rule 4(xii) of Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended.
